TOWN OF PORT HEDLAND WASTE AMENDMENT LOCAL LAW 2022

Under the powers conferred by the *Waste Avoidance and Resource Recovery Act 2007* and the *Local Government Act 1995*, and under all other powers enabling it, the Council of the Town of Port Hedland resolved on 23 February 2022 to make the following local law.

PART 1—PRELIMINARY

1. Short Title

This is the *Town of Port Hedland Waste Amendment Local Law 2022*.

2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

3. Principal local law

This local law amends the *Town of Port Hedland Waste Local Law 2020*, published in the *Government Gazette* on 11 January 2021.

4. Clause 2.6 amended

- (1) In subclause 2.6(b), insert “and” after “person;”
- (2) Subclause 2.6(c) is deleted.
- (3) Subclause 2.6(d) is to be re-numbered to 2.6(c).

PLANNING AND DEVELOPMENT ACT 2005
APPROVED LOCAL PLANNING SCHEME AMENDMENT

City of Albany

Local Planning Scheme No. 1—Amendment No. 36

Ref: TPS/2699

It is hereby notified for public information, in accordance with section 87 of the *Planning and Development Act 2005* that the Minister for Planning approved the City of Albany Local Planning Scheme amendment on 22 February 2022 for the purpose of—

1. In Schedule 4 Special Use Zones, for Special Use Zone No.23 (SU23), delete the Special Uses of “Aged Persons’ Village” and “Nursing Home”.
2. In Schedule 4 for SU23, add the Special Uses of—
 - Child Care Premises
 - Community Purpose
 - Recreation-Private
3. In Schedule 4 for SU23, modify the “Conditions” column by—
 - Adding “as a ‘D’ use” after “Local Government” in Condition 1.
 - Replacing “Structure Plan and/or Local Development Plan and Design Guidelines” with “Local Development Plan” in Condition 1.
 - Replacing “Design Guidelines” with “Local Development Plan” in Condition 2.
 - Inserting ‘A child care premises shall be limited in area and incidental to the predominant use of the land as determined by the ‘Local Government’.
 - Inserting ‘Any development application for Child Care Premises is to be accompanied by an assessment against State Planning Policy 5.4 Road and Rail Noise’.
4. Rezone a portion of Lot 1004 Viastra Drive, Lange from ‘Special Use (SU23)’ to ‘Highway Commercial’.
5. Within clause 4.8 site and development requirements insert new clause 4.8.11 to read—

Additional Site and development requirements for areas covered by structure plan or local development plan

The Table sets out requirements relating to development that are included in precinct structure plans, structure plans approved before 19 October 2015 and local development plans that apply in the Scheme area.

6. In Schedule 4 Special Use Zones, for Special Use Zone No. 23, insert ‘Portion’ before Lot 1004 Viastra Drive, Lange, in Description of Land’.
