1.0 INTRODUCTION

Local governments are required by the Local Government Act 1995 to conduct a periodic review of their local laws.

Section 3.16(1) requires that within a period of 8 years from when a local law commences, or a report of the review of a local law was accepted, a local government is to carry out a review of the local law to determine whether or not it considers that it should be repealed or amended.

The Department of Local Government has prepared a Register of Local Laws for each local government within Western Australia. The Register is comprehensive however the Department acknowledges that it does contain some inaccuracies and that the responsibility rests with each local government to verify and confirm what local laws are in effect for their district. Notwithstanding the potential for inaccuracies within the Register, the Register is the best source for commencement of a local law review.

This desktop review has utilised the Department of Local Government's Register as the primary document source for commencing the review. There is no other evidence that other local laws, apart from those listed in the Register, may be in existence.

The remainder of this report examines in summary form the current state relating to local laws, outlines which local laws should be repealed immediately because they are obsolete or defunct due to new legislation, and those local laws that should form part of the review process.

2.0 TOWN OF PORT HEDLAND CURRENT LOCAL LAWS

2.1 REVIEW OF LOCAL LAWS REGISTER

The following table details the Department of Local Government Register of local laws in force for the Town of Port Hedland.

The desktop review has identified a number of local laws that have been previously repealed. It is advisable to notify the Department of Local Government of the amendments required to the Register so it can be updated.

Recommendation:

That the Town write to the Department of Local Government and advise of the updates required to the Local Laws Register and provide copies of the relevant Government Gazettes to confirm those local laws that have been repealed but still appear on the Register.

2.2 SUMMARY OF CURRENT LOCAL LAWS

The following provides an overview of each current local law and details some issues that will require further consideration on the appropriate course of action for each local law.

2.2.1 Control of Dogs Local Law – 12 November 1954

This local law has been superseded by the Towns Dogs Local Law gazetted on 2 October 1998.

It is obsolete and should be repealed.

2.2.2 Prevention of Damage to Streets Draft Model By-Law No. 1 – 15 May 1963

This local law has been superseded by the provisions contained in the *Local Government (Miscellaneous Provisions) Act 1960*.

It is obsolete and should be repealed.

2.2.3 Old Refrigerators and Cabinets Local Law– 4 June 1970

This local law was introduced to prevent people from becoming locked in old refrigerators and required people disposing of them to remove the door.

These types of refrigerators have not been manufactured for many years, making the local law obsolete.

2.2.4 Safety, Decency, Convenience and Comfort in Respect of Bathing – Draft Model By-Law No.14 – 6 October 1970

This local law has been superseded by the Criminal Code and other state legislation.

It is obsolete and should be repealed.

2.2.5 Clearing of Land and Removal of Refuse, Rubbish and Disused Material Local Law – 12 February 1971

This local law is superseded by the provisions of Section 3.25 and Schedule 3.1 of the *Local Government Act 1995*.

It is obsolete and should be repealed.

2.2.6 Removal of Verandahs Local Law – 12 February 1971

This local law has been superseded by the provisions of the Building Code of Australia.

It is obsolete and should be repealed.

2.2.7 Control and Management of Port Hedland Civic Centre Local Law – 23 January 1973

This local law deals with the hiring of the Civic Centre and the conditions of hire that apply, including the fees applicable.

The conditions of hire for the Civic Centre can be simply managed through a Council policy, and the Local Government Act 1995 sets the requirements in relation to hire fees that apply.

Given the above, the local law is considered obsolete and should be repealed.

2.2.8 Parking Facilities Amendment Local Law – 24 October 1980

The Principle local law relating to this amendment local law was repealed on 3 April 1998. Unfortunately in the repeal of the Principle local law, the gazettal dates of the amendments were not specified, hence are deemed not to have been repealed.

As the Principle local law has been repealed, the amendment should also be repealed.

2.2.9 Control and Management of Port Hedland Civic Centre Amendment Local Law – 16 July 1982

The Principle local law relating to this amendment is recommended for repeal under section 2.2.7 due to it being obsolete.

Given the above the amendment local law should be repealed.

2.2.10 Parking Facilities Amendment Local Law – 15 April 1983

The Principle local law relating to this amendment local law was repealed on 3 April 1998. Unfortunately in the repeal of the Principle local law, the gazettal dates of the amendments were not specified, hence are deemed not to have been repealed.

As the Principle local law has been repealed, the amendment should also be repealed.

2.2.11 Control and Management of Port Hedland Civic Centre Amendment Local Law – 31 October 1986

The Principle local law relating to this amendment is recommended for repeal under section 2.2.7 due to it being obsolete.

Given the above the amendment local law should be repealed.

2.2.12 Repeal Local Law – 7 November 1986

This local law repealed a series of obsolete and defunct local laws dating back to the 1920's.

No further action is required in relation to this local law.

2.2.13 Caravan Parks and Camping Grounds Draft Model By-Law – 7 November 1986

This local law is superseded by the *Caravan Parks and Camping Grounds Act 1995*, and the *Caravan Parks and Camping Grounds Regulations 1997*.

It is obsolete and should be repealed.

2.2.14 Repeal Local Law – 10 July 1987

This local law repealed the Controlling Reserves and Camping By-Law gazetted on 19 October 1955.

No further action is required in relation to this local law.

2.2.15 Dogs Amendment Local Law – 4 March 1988

The Principle local law relating to this amendment local law was repealed on 2 October 1998. Unfortunately in the repeal of the Principle local law, the gazettal dates of the amendments were not specified, hence are deemed not to have been repealed.

As the Principle local law has been repealed, the amendment should also be repealed.

2.2.16 Parks, Recreation Grounds and Public Reserves Amendment Local Law – 2 September 1988

The Principle local law relating to this amendment local law was repealed on 8 June 1999. Unfortunately in the repeal of the Principle local law, the gazettal dates of the amendments were not specified, hence are deemed not to have been repealed.

As the Principle local law has been repealed, the amendment should also be repealed.

2.2.17 Conduct of Proceedings and the Business of Council Local Law – 17 November 1989

This local law is superseded by the current Standing Orders local law, which was gazetted on 25 March 1997.

Given the above the local law should be repealed.

2.2.18 Parks, Recreation Grounds and Public Reserves Amendment Local Law – 9 July 1993

The Principle local law relating to this amendment local law was repealed on 8 June 1999. Unfortunately in the repeal of the Principle local law, the gazettal dates of the amendments were not specified, hence are deemed not to have been repealed.

As the Principle local law has been repealed, the amendment should also be repealed.

2.2.19 Dogs Amendment Local Law – 21 January 1994

The Principle local law relating to this amendment local law was repealed on 2 October 1998. Unfortunately in the repeal of the Principle local law, the gazettal dates of the amendments were not specified, hence are deemed not to have been repealed.

As the Principle local law has been repealed, the amendment should also be repealed.

2.2.20 Removal and Disposal of Obstructing Animals or Vehicles Draft Model By-Law No 7 – 9 December 1994

This local law is superseded by the provisions of Section 3.25 and Schedule 3.1 of the *Local Government Act 1995*, and the *Local Government (Miscellaneous Provisions) Act 1960*.

It is obsolete and should be repealed.

2.2.21 Standing Orders Local Law – 25 March 1997

This local law is currently in force and is utilised to regulate the meetings of the Council of the Town of Port Hedland.

The Council may wish to give consideration to a more contemporary local law with more clear numbering and distinct headings.

As a minimum, the Council should consolidate the local law by including all amendments, and then repeal the amendments made on 2 October 1998, 8 June 2001, 29 January 2002 and 1 July 2005.

2.2.22 Parking Local Law – 3 April 1998

This local law is currently in force and regulates parking within the district of the Town of Port Hedland.

Specific amendments will be required to this local law to bring it into alignment with state legislation, such as definitions referring to the *Road Traffic Code 2000*.

The Council may wish to give consideration to a more contemporary local law given that drafting amendments will be required and the local law is over 14 years old.

2.2.23 Standing Orders Amendment Local Law – 2 October 1998

See Section 2.2.21 above.

2.2.24 Dogs Local Law – 2 October 1998

This local law is currently in force and regulates the keeping of dogs within the district of the Town of Port Hedland.

Specific amendments will be required to this local law to bring it into alignment with recent directions from the Joint Standing Committee on Delegated Legislation, particularly in relation to Clause 6 – Prohibited Places.

The Council may wish to give consideration to a more contemporary local law given that drafting amendments will be required and the local law is over 14 years old.

2.2.25 Dogs Amendment Local Law – 26 February 1999

See Section 2.2.24 above.

2.2.26 Cat Control Local Law – 14 May 1999

The *Cat Act 2011* received Parliamentary assent on 9 November 2011 and will be phased in:

- Phase 1 by 1 November 2012; and
- Phase 2 by 1 November 2013.

It is suggested that Council review the Cat Control local law to the new *Cat Act 2011* and if Councils concerns are addressed in the Act, they give consideration to the repeal of the Cat Control local law.

Once all aspects of the legislation, including Cat Regulations are finalised, the Council can then evaluate whether there is a need for a new Cat Control local law.

2.2.27 Reserves and Foreshores Local Law – 8 June 1999

This local law is currently in force and regulates access to, and activities that can be carried out on, reserves and foreshores within the district of the Town of Port Hedland.

Council may wish to give consideration to implementing a Local Government Property Local Law which will cover matters relating to all local government property, and repeal this local law and others. This will streamline the number of local laws in place and make it easier for staff referring to local laws.

2.2.28 Aquatic and Recreation Centres Local Law – 8 June 1999

This local law is currently in force and regulates the use, control and management of aquatic and recreation centres within the district of the Town of Port Hedland.

Council may wish to give consideration to implementing a Local Government Property Local Law which will cover matters relating to all local government property, and repeal this local law and others. This will streamline the number of local laws in place and make it easier for staff referring to local laws.

2.2.29 Town of Port Hedland International Airport Local Law – 17 September 1999

This local law is currently in force and regulates the access to, use, and the conduct of business at the airport.

Council may wish to give consideration to implementing a Local Government Property Local Law which will cover matters relating to all local government property, and repeal this local law and others. This will streamline the number of local laws in place and make it easier for staff referring to local laws.

2.2.30 Town of Port Hedland International Airport Amendment Local Law – 19 November 1999

See Section 2.2.29 above.

2.2.31 Cemeteries Local Law – 10 January 2000

This local law is currently in force and regulates the administration of the cemeteries, the burial of deceased persons and the use of the cemeteries within the district of the Town of Port Hedland.

Specific amendments will be required to the local law to bring it into alignment with legislative requirements, particularly Clause 8.20 which will require the removal of any reference to the Cemeteries Act.

The Council may wish to give consideration to a more contemporary local law given that drafting amendments will be required and the local law is over 12 years old.

2.2.32 Holiday Cabins and Chalets Local Law – 28 January 2000

This local law is currently in force and regulates the registration and health standards of holiday cabins and chalets within the district of the Town of Port Hedland.

This local law is superseded by superior legislation (Building Code of Australia and Health Act), except the registration requirement and payment of an annual fee to Council.

The continuation of the registration and fee requirement would seem to be unjustifiable in this context.

2.2.33 Health Local Laws – 22 March 2000

This local law is currently in force and regulates health standards within the district of the Town of Port Hedland.

This local law will require specific amendments in the following areas:

Food Act 2008

Amongst other things, the Food Act 2008 regulates 'food businesses', including their registration, conduct and the imposition of fees and charges by local governments. This Act made significant amendments to the Health Act including:

- The repeal of those Parts that deal with eating houses, including the removal of a local government's powers to make local laws in respect of eating houses (Part V, Division 3); and
- The removal of other local law making powers such as sections 134(49), 52a, 199(14), 207 and 220.

The intention of the Food Act is to remove anomalies and different compliance regimes that exist between the large number of local laws that operate within the State, while at the same time protecting public health and maintaining the role that local governments play in maintaining standards.

Waste Avoidance and Resource Recovery Act 2007

The most relevant provisions of the *Waste Avoidance and Resource Recovery Act* (WARR) came into force on 1 July 2008.

This Act repealed various provisions of the Health Act 1911 that dealt with the powers of local governments in relation to the collection and removal of rubbish, and had the effect of transferring the powers of a local government to make local laws about waste to the WARR Act (item 4 of Schedule 4).

However, there have been ultra vires issues with the current Waste local laws previously approved and the matter is still with the Crown Solicitors to resolve the issues. It is suggested that the provisions relating to Waste remain under the Health Local Law until such time as the issues concerning the Waste local laws are resolved.

2.2.34 Signs, Hoardings and Bill Postings Local Law – 3 August 2000

This local law is currently in force and regulates the erection, attachment and affixing of any sign or advertising device to any land or building within the district of the Town of Port Hedland.

It is noted that the Department of Local Government discourages local governments from making local laws regulating signage on private property. Operational Guideline No 16, released in September 2006, states that:

Some local governments are attempting to deal with signage on private land through their signs local laws, whereas the correct place for dealing with this issue is under their town

planning scheme [sic]. Signs local laws should only deal with the issue of signage on local government property.

Reference is also made to the 28th Report of the Joint Standing Committee on Delegated Legislation, which specifically focuses on local laws regulating signs and advertising devices, released in April 2009. Recommendation 4 of the report on page 32 makes it very clear that future local laws dealing with signs and advertising devices must address non-planning and development matters only.

The Council may wish to consider its approach to signs and advertising devices in light of the matters detailed above.

2.2.35 Trading in Public Places Local Law – 1 September 2000

This local law is currently in force and regulates the selling or hiring of goods and services in public places within the district of the town of Port Hedland.

The Council may wish to give consideration to a more contemporary local law given that the local law is over 12 years old.

2.2.36 General Provisions Local Law – 1 December 2000

This local law is currently in force and regulates the removal of goods from public places; the control and management of Council property; and street lawns and gardens.

Council may wish to give consideration to implementing a Thoroughfares and Trading in Public Places Local Law and a Local Government Property Local Law which will cover matters relating to thoroughfares, trading in public places and all local government property, and repeal this local law and the Trading in Public Places local law. This will streamline the number of local laws in place and make it easier for staff referring to local laws.

2.2.37 Health Amendment Local Laws – 19 January 2001

See Section 2.2.33 above.

2.2.38 Signs, Hoardings and Bill Postings Local Law – 2 February 2001

See Section 2.2.34 above.

2.2.39 Standing Orders Amendment Local Law - 8 June 2001

See Section 2.2.21 above.

2.2.40 Standing Orders Amendment Local Law – 29 January 2002

See Section 2.2.21 above.

2.2.41 Standing Orders Amendment Local Law – 1 July 2005

See Section 2.2.21 above.

2.2.42 Reserves and Foreshores Amendment Local Law – 23 December 2008

See Section 2.2.27 above.

Where the above table identifies local laws for repeal, it is suggested the necessary statutory procedures be commenced to effect their repeal as soon as possible.

4.0 PERIODIC REVIEW OF LOCAL LAWS

4.1 Statutory Review Process

Section 3.16 of the *Local Government Act 1995* states as follows:

3.16. Periodic review of local laws

- (1) *Within a period of 8 years from the day when a local law commenced or a report of a review of the local law was accepted under this section, as the case requires, a local government is to carry out a review of the local law to determine whether or not it considers that it should be repealed or amended.*
- (2) *The local government is to give Statewide public notice stating that —*
 - (a) *the local government proposes to review the local law; and*
 - (b) *a copy of the local law may be inspected or obtained at any place specified in the notice; and*
 - (c) *submissions about the local law may be made to the local government before a day to be specified in the notice, being a day that is not less than 6 weeks after the notice is given.*
- (2a) *A notice under subsection (2) is also to be published and exhibited as if it were a local public notice.*
- (3) *After the last day for submissions, the local government is to consider any submissions made and cause a report of the review to be prepared and submitted to its council.*
- (4) *When its council has considered the report, the local government may determine* whether or not it considers that the local law should be repealed or amended.*

4.2 Local Laws for Review

The periodic review of local laws, required by Section 3.16 of the *Local Government Act 1995*, can now be narrowed down to the local laws identified in the Table below.

Once the statutory advertising period required for the review process is concluded, a report is to be submitted to Council on the submissions received (if any).

The Council can then consider what specific action it wishes to take in relation to the local laws reviewed and commence the relevant action in accordance with Section 3.12 of the *Local Government Act 1995*.
